Party times are available at the Mill Valley Aquatic Center as follows:

Poolside with a viewing window (Cove Room) Saturday & Sunday
12:15pm – 2:15pm & 3:00pm – 5:00pm

Lobby-side with outside play are (Kidzwatch Room) Saturday & Sunday
12:15pm – 2:15pm & 3:00pm – 5:00pm

Birthday package consists of swimming for the first hour and then move into the party room for The final 45 minutes. Free adult deck watcher admission.

FEE: **\$225 (1-15 Children & 4 Adults)**
 \$250 (16-25 Children & 4 Adults)
 \$100 Room/Security deposit

Reservations are taken in person at the Community Center on a first come first served basis. The full fee plus damage/security deposit must be paid to reserve the party date. A 30 day notice of cancellation is required to receive a full refund. Less than 30 day notice of cancellation is loss of \$100 deposit. Less than 7 day notice is a loss of the \$100 deposit and 50% of the party fee. In the event that the Community Center cancels the party, you will receive a full refund.



Party group must follow the following pool rules and cooperate with Facility staff.

Swim Center Guidelines

General Information:

- **These guidelines have been established for the health, safety and fun of all.**
- Children 6 & under must be accompanied by an adult who is actively participating in the water and at arms length of child/children at all times.
- Children age 7, 8 & 9 must be accompanied by an adult or responsible 16+ year old.

Health Rules:

- Children 3 & under must wear a disposable diaper & a re-useable diaper; no exceptions! Swim diapers can be purchased at the Fitness Center desk.
- All swimmers must take a cleansing shower before entering the pool or spa.
- All swimmers must wear a swimsuit. No shorts, cut-offs or tee-shirts allowed in the pool or spa.
- No food, drink, gum or tobacco products allowed in the pool area. **NO GLASS OF ANY KIND.** (water in a plastic bottle OK).
- Persons under the influence of alcohol or drugs **WILL NOT** be allowed to use the facility.
- Persons with a communicable disease transmissible via water, wearing bandages, having open cuts or wounds **WILL NOT** be allowed to use the facility.

Safety Rules:

- **Only** Coast Guard approved floatation devices are allowed. No Water Wings, inflatable tubes or similar.
- No running on the deck.
- Rough play, pushing and fighting are not allowed in the facility.
- **NO DIVING.** Feet first entries only.
- Back dives, back jumps, flips and splash jumps are prohibited.
- Mask, snorkel and fins only allowed during Lap Swim.
- Kick boards; pull buoys, paddles and lesson/class equipment not available for use during Open Swim.

Spa Rules:

- **Children 14 & under must be accompanied at all times by an adult in the spa. Adult must be in the water in swimsuit with the children.**
- **Two children per adult**
- **Spa capacity is 11.**

Slide Rules:

- Children must be 48 inches tall to use the slide.
- Sliding feet first on your back only.
- Must follow the direction of the slide guard.

Lockers:

- For the safety of your belongings lockers are available. Bring your own lock.
